## **COMMUNITY FLOOD RESILIENCE SUPPORT**

Communities can sign up for flood warnings. Flood wardens are appointed who act upon a flood warning and would help co-ordinate preventative measures.

There is a pool of pumps which are held by Yorkshire Water.

RDC held an overview and scrutiny meeting two weeks before the Parish Liaison meeting for both villages and towns. RDC, NYCC and the EA were represented. A flood study with funding from DEFRA went to committee before Christmas 2015.

## **EMERGENCY PLANNING – RISK REGISTER**

A template is created between the EA/Blue light services/Utilities/Councils.

NYCC template needs people in the community to receive flood warnings. This role will include locating vulnerable people in the community.

In the event of evacuation from homes - school halls, pubs and village halls would be used.

The community group would take action before the blue lights etc. British Red Cross first aid training was mentioned and the Yorkshire Ambulance – defibrillator's in the community.

NYCC are happy to speak to Parish Councils and the details are online.

## There were questions/observations from the floor:

Regarding the risk register, will fracking be looked in to?

A gas leak at Great Habton was mentioned and the fact that the co-ordinated response did not work.

Seismic activity and fracking was mentioned. They are learning from Lancashire County Council re seismic activity. Looking to LCC for best practice.

Will there be extra staff at NYCC?

Robin Derry or another NYCC representative asked to come back re fracking to talk at another Parish Liaison meeting.

Tadcaster bridge was mentioned and the fact that the community were without utilities as the utilities ran across the bridge that collapsed.

**LIVING WELL** 

Living well is a new service which aims to prevent high levels of health and social care. Its goal is to reduce ongoing support and care.

Members of the community can become socially isolated and lose confidence. This could be following bereavement. Guidance and advice is given one to one.

There is a network of support which can identify simple changes to remove barriers to an independent life.

Support is available for up to 12 months. A strong communities team work with living well.

Living Well Team – 01609 780780 – 24 coordinators across North Yorkshire.

It was suggested that Living Well notify Parish Councils by letter about the service. More information on the NYCC website.

## **DOING WHAT MATTERS FOR RYEDALE**

Devolution - combined authority - ongoing.

Looking at services for communities - corporate plan.

60% cut in budget over 7 years.

Plan – village agents and town wardens – voluntary?

Encouraging collectively working together to make a ward more efficient.

Two Pilot Schemes now running:

Pilot 1 - Amotherby Ward – Ward plan.

Pilot 2 - Helmsley – Best market town a great success.

The National Park, District Council, County Council and Town Council all have land ownership/car parking.

Value needs to be added as a democratic council. Actions need to be legal, affordable and make common sense.

Specifics: Coach parking charges in Helmsley have gone.

Public toilets in Helmsley being looked at.

Objectives: economic growth and attractiveness of the town.

#### **QUESTIONS**

Q. RDC recommended refusal of the Third Energy planning application to frack at Kirby Misperton. Will RDC support/help fund the JR?

Reply - The matter has not been discussed and cannot say if it will be discussed. RDC had a bad JR experience. They feel they would be out of their depth. The duty of the district council is to represent and put forward to NYCC and they continue doing so.

Q. Will RDC inform Parish Councils with the facts on fracking?

Reply – unfortunately RDC do not have the officers with that expertise and RDC could not accept the cost. RDC held a meeting called 'Unpacking Fracking' at the Milton Rooms.

Ward meetings were discussed so that Parish Councils can be more in touch with District Councillors \*\* it was agreed that the Parish council would write to Cllr Val Arnold to suggest a ward meeting to discuss issues that affect our locality. Mrs Garrett to write a letter.

# 7. Consider having a representative on the Third Energy Community Liaison Group.

Mrs Garrett has received an email from Mercury Communications, the PR company operating on behalf of Third Energy, asking if the Parish Council would consider having a representative on the Community Liaison Group. The request was discussed at length with the initial response being that it seemed almost a 'box-ticking' exercise considering it was after the planning application had been approved. However, further discussion, including input from Mr Swift from the floor, took place where it was deemed appropriate to have a

member of the Parish Council on the committee in order to feedback concerns and also to be able to keep up to speed with the progress on site and inform residents of forthcoming works and ensure Third Energy is fully accountable to residents. Mr Collinson agreed to be the representative. Mrs Garrett to confirm to Mercury Communications.

#### 8. Winter Maintenance

With the difficulty of actually finding the right person to speak to at NYCC with regards to ordering grit and the failure of NYCC to supply any to Little Barugh in January, Mrs Garrett suggested Mrs Houlston contact Simon Thackray as he seemed to have contacts. Mrs Houlston said she would and would forward information to Mr Collinson. It was voted that we should spend £180 as per budget on salt and grit. It was resolved that Mr Collinson would arrange for salt and grit to be arranged for the required locations in Little Barugh and at Wandales. Great Barugh boxes were currently still stocked.
