Andy - sub surface Third Energy

Fracking sheet sand not shale. Chemistry very much the same as shale.

Ground water contamination in America -could not answer why this has happened.

One mother borehole can have between 10-50 laterals. Therefore 5-10 mother boreholes on one site.

Traffic Management Plan

According to TE there was a second route in the TMP but Police revised and been taken out. Second route not surveyed.

According to Dave Hannon (NY Police) there is a second route through Great Habton.

Asked for assurance from TE that they would not being in convoys of HGV'S in the middle of night. They could not give me their assurance as if they are told to do so by the police they will.

Dave Hannon (NY Police) stated at the Community Police meeting that he had stipulated to TE that there will be no traffic movements at night.

Waste Disposal

Have not released contract information yet.

Flaring

Two wells on site at KM8. Second well no intention of drilling but came with permission to flare.

COMMUNITY POLICE MEETING – Dave Hannon- Silver Commander, Tom Knox – NYCC – 5th Sept 17

There has to be a balance between the lawful business of TE and the right to peaceful protest.

On the 5th Sept the police were still waiting for details of the TMP from TE.

Update - TMP is now signed off.

"Safe neighbourhood style policing." The operation has been running since Nov 2014. Operation Kingfisher.

There are additional resources if the protest is not peaceful.

Up to 50 officers can be put in at KM8.

No overtime for police, rest days cancelled. Asked if TE will pay for policing, answer NO.

Re Dave Hannon, Third Energy will be disrupting our daily lives, 300 vehicle movements in and 300 out. Well already drilled. It will attract National and International attention.

Dave Hannon has met with TE 3 times.

Will allow slow walking for 20 minutes. Once in the morning, once in the afternoon. (not in village).

PLO – intelligence gathering role (blue bibs)

5 CCTV cameras set up for the duration of the work. Able to pixelate, detect any disorder. Cameras will go once work complete.

Questions asked about access to footage if needed. Needs reporting to the police asap.

There is a secondary route, confirmed.

Police have almost pleaded with TE about weekend working. TE may not get a police response on a weekend.

Challenge – TMP – school buses. Police have asked for movements after 9am. Police have stipulated no movements at night.	
No one	will be arrested for watching.
