

**Draft Minutes of the Annual Meeting of the Great and Little
Barugh Parish Council held via Zoom on Thursday 6th May
2021 following ordinary meeting**

1. Election of Chair & acceptance of office
Councillor Garrett nominated Councillor Houlston, this was
seconded by Councillor Metcalfe.
2. To receive apologies and note attendance.

3. To approve the minutes of the last Annual Meeting of The
Council
The minutes were duly approved and signed.
4. To consider any matters arising.
Councillor Garrett informed that the Consultation on Permitted
Development for gas extraction was rejected by the
Government as was NSIP (Nationally Significant Infrastructure
Project. That year we were also looking at the possibility of

adopting the phone box for the defibrillator which obviously has moved on since then and indicates how long it has taken.

5. To review sub-committee

Councillor Houlston asked if we wanted to continue with the Sub-committee on Fracking, it was resolved we did not require it now.

6. Responsible Financial Officers Report for 2020/21

Councillor Houlston read through the RFO's report for 2020/21, through the P & L. The audited accounts were approved and signed off. Copy of P & L attached.

7. To review Exercise of Public Rights.

Councillor Houlston explained this is to notify the public that there is a timeframe for examining the accounts. It was noted this year they will be displayed from the 14th June 2021.

8. Confirmation of arrangements for insurance

Public Liability Insurance is through Zurich as in previous years.

11. To review Parish Correspondence.

Councillor Garrett stated she had attended the Community Liaison Meetings online with Third Energy. They are moving away from gas extraction and have no plans to frack. They are exploring geothermal and renewables. They are also exploring methods of properly sealing abandoned wells and are testing methods to do this. This could have an impact globally if successful. They are possibly now not using the generating station at Knapton for gas from the grid following the Government's announcement surrounding the use of gas, they are looking at renewable resources.

The Golden Lion ACV has been approved.

The application for a license to run a haulage business from Stainers Farm was withdrawn.

There is the intention to replace the footpaths at Little Barugh over the summer months, Mrs Garrett was notified last year that a Civil Engineering company would be doing the work in the good weather. Great Barugh's pavements are still a work in progress.

Councillor Houlston stated we had had the funding approved for the VAS and gateway signs, the projects should be underway soon.

The decision was made not to adopt the telephone box in Great Barugh after a lot of correspondence between the Council, BCG, NYCC and BT.

There has been further correspondence regarding the road between Great Barugh and Kirby Misperton. It is not getting any better and there are some really bad areas. Mrs Houlston suggested another trip out to take photos and get the damage on the Parish Portal. It gets missed every time they are doing road works. Mrs Houlston stated the white lines at the top of Barugh still haven't been done.

12. To set dates for future Ordinary Meetings

Another date will be set as soon as possible when we know there are suitable meeting places open following relaxation of restrictions. Hopefully towards the end of May.
